

Unique Valuation Focus

Our unique valuation framework attempts to ensure adequate levels of risk-adjusted returns potential for each investment. We aim to preserve capital against credit losses, promote discipline, limit biases toward pursuing high yields, and focus our analysts' research efforts.

Credit Quality letter ratings are provided by Standard and Poor's, Moody's, and Fitch and are presented as the higher of the three ratings. When a security is not rated by Standard & Poor's, Moody's, or Fitch, the highest credit ratings from DBRS and Kroll may be used. Absent a rating from these agencies, we may display Private Credit ratings, if permitted by the issuer, which could include ratings from Egan-Jones Ratings Co. Credit ratings reflect the credit quality of the underlying issues in the portfolio and not the portfolio itself. Credit rating exposure and composition are subject to change.

Issues with credit ratings of BBB or better are considered to be investment grade, with adequate capacity to meet financial commitments. Issues with credit ratings below BBB are considered speculative in nature and are vulnerable to the possibility of issuer failure or business interruption.

Duration is a measure of the portfolio's return sensitivity to changes in interest rates.

Yield to Maturity is the rate of return the portfolio would achieve if all purchased bonds and derivatives were held to maturity, assuming all coupon and principal payments are received as scheduled and reinvested at the same yield to maturity. The objective of our Multisector Fixed Income Strategy is to provide attractive total return with a focus on income and preservation of capital over the long term. The strategy seeks to deliver excellent after-tax returns in excess of industry benchmarks through market cycles. The composite is comprised of all fully discretionary, fee paying multisector fixed income accounts with an initial investment equal to or greater than \$10 million and invested in a broad range of taxable bonds. The accounts have durations that generally range between 2 and 5 years, invest across investment-grade and non-investment-grade ("high yield") securities and instruments, and possess characteristics that demonstrate less awareness to market benchmarks. Accounts that subsequently fall below \$9.25 million are excluded from the Composite. As of 7/1/2022 the Unconstrained Credit - Fixed Income composite was renamed BBH Multisector Fixed Income, and the description was slightly adjusted in order to better align with the investment strategy.
